## **Winter Rates in Effect: October 16<sup>th</sup> – April 13<sup>th</sup>**

The following rates are for the Winter Seasonal Stay 2020-2021

30 amp site is \$4250.00 plus GST.

50 amp site is \$4600.00 plus GST.

These prices include hydro.

The seasonal rate is only valid from Oct. 16th to April 13<sup>th</sup>. We will require a \$500 non-refundable deposit to make the booking for you.

Additional fees apply for storage, pets etc.

We have enclosed the winter seasonal stay information sheet. The rules apply to all campers and visitors staying in or visiting the campground. As well, we've enclosed a Winter Stay Request Form that is due back to us with the deposit.

1. **Winter Seasonal Program is from October 16<sup>th</sup> to April 13<sup>th</sup>.** A total maximum stay of 180 days.
2. Your site fee includes your RV unit and 2 vehicles. 1 vehicle can be parked at your site. 2<sup>nd</sup> vehicles are to be parked in the designated parking. No parking on grass. All vehicles/RV units/ cargo trailers must display valid insurance. No excessive noisy vehicles are permitted. Cargo trailers/dolly wheels must be parked in a designated storage site. Fees apply.
3. Site fees are based on 2 adults. Fees for additional occupants. Please see staff for pricing.
4. Fort Camping is gated 24 hours. A gate card will be issued upon check-in. There is a \$50 charge for any lost or un-returned gate cards at check-out. Maximum 2 gate cards per site.
5. Maximum 2 pets per site. \$50 seasonal fee. Dogs & cats must be leashed at all times and never left unattended. Dog waste disposal stations are located in the park; owners are responsible for waste cleanup. Your "permit to occupy the site" may be revoked if your pet disturbs other guests or is deemed aggressive.
6. No site alterations are permitted. No decks, no freezers & no fridges. No outdoor carpets on the grass; gravel only. Only outdoor furniture is to be kept on the site. Any miscellaneous items should be removed. No tarps or generators are permitted. Add-a-rooms are fine. No fencing or barriers are permitted with the exception of a small pet enclosure no larger than 5' x5' and 3' high. Enclosures are restricted to the gravel pads.
7. Visitors are to park in the day use parking lot and walk-in. Guests are responsible for the behavior of their visitors while here. Day park hours can be found posted at the entrance to the parking lot. Vehicles left after hours may be towed. Alternately, guests can meet visitors at the front gate to let in with gate card. Visitors to park in designated additional parking inside the campground.
8. Proof of Third Party Liability will be required
9. No excessive noise at any time. Campfires are permitted until 11pm
10. Sites are for the exclusive use of the registered campers. Sites are not to be sublet.
11. The speed limit within the park is a maximum of 10 Km per hour. Please follow all signage in the park.
12. **Full payment is due at check-in. There are no refunds for early departures.**
